### **CALL TO ORDER:**

#### **WELCOME AND OPENING COMMENTS:**

Mayor Beehan welcomed everyone to the meeting and had everyone introduce themselves.

### **APPROVAL OF MINUTES:**

Mr. Stout distributed a copy of the June 25, 2013 minutes to the group.

There was **motion** by Woody to approve the notes as submitted, **second** by Frank. On a voice vote the **motion passed unanimously**.

### **Discussion and Necessary Actions**

Grant Report from the City of Oak Ridge – Janice McGinnis gave the grant report. (see attached).
 Ms. McGinnis stated the grant must be file with the State by the end of August. A motion by Ms.
 Frank was made to carry over money from last year budget with a second from Mr. Woody on a

- voice vote passed unanimously. A specific use of the money would be for the study of the second CERCLA landfill.
- <u>Budget Amendments</u> Ms. McGinnis outlined the recommended budget amendments.(see attachment).
- Work Plan Ms. Fitzgerald distributed the recommended work plan. Ms Fitzgerald went over the
  work plan to be submitted to the State. Mr. Woody asked that in section A4 it include risk
  identification. Motion to adopt the work plan with the addition of the risk identification being
  added to section A4 was made by Ms. Frank and a second by Mr. Grider on a voice vote passed
  unanimously.

### **UPDATES FROM INTERGOVERNMENTAL PARTNERS**

- Emergency Planning Mr. Hose, TEMA and Mr. Rector, TDEC discussed the DOE Y-12 exercise that was held on August 14. Mr. Hose said some counties will be updating their Basic Emergency Operations Plan. The plans are update every 5 years.
- Environmental Management Mr. Rector discussed that the mercury in fish still remains at higher level than are accepted by the State. Mr. Rector said that the State has questions regarding whether the proposed water treatment plant would produce the desired results for mercury clean up. The plan is still under EPA and TDEC review. Mr. Rector added that the proposed review of the second CERCLA landfill is also timely. Motion made by Ms. Frank and by Mr. Woody for TDEC to give a briefing on mercury and the effects on the Reservation and the communities around the Reservation and the underground water plume samplings from Jones Road to Rogers Ridge Lane.
- Nuclear Waste Legislation There was a hearing for legislation on the nuclear waste disposition
  and storage. Action item: ORRCA to take a position on the nuclear waste disposition and storage
  facility.

# Work Plan for Oak Ridge Reservation Communities Alliance (ORRCA) FY14 (July 1, 2013 thru June 30, 2014)

### Scope of Services:

A.2. The Grantee shall support implementation of the Tennessee Oversight Interlocal Agreement (TOIA)

The TOIA will continue to serve as the framework for the establishment and operation of ORRCA. ORRCA shall strive to conduct outreach and educational activities to potentially affected local governments, even if they are not signatories to the TOIA.

A.3. The Grantee shall promote local government involvement and public awareness in the continued operations of the Oak Ridge Reservation facilities, including, but not limited to the environmental restoration process.

ORCCA will continue to collaborate among the regional local governments to promote better understanding of the continued operations of the Oak Ridge Reservation facilities, including the environmental management and emergency response planning programs. Participation with DOE and TDEC officials in meetings, such as those listed in this plan as "Upcoming Meetings of Interest," will be instrumental in educating local officials in support of the grant scope.

During FY14 particular emphasis will be placed on:

- Emergency Response Planning and Training related to the ORR
- Implementation of Federal Facility Agreement "Appendix E" Milestones (attached)
- A.4. The Grantee shall disseminate accurate and factual information concerning present or proposed activities related to continued operations of the Oak Ridge Reservation facilities.

During FY14 particular emphasis will be placed on:

- Evaluating public education opportunities in consultation with DOE's Site Specific Advisory Board and other local and regional organizations
- Educating local officials and other stakeholders from other DOE sites about ORR facilities and activities
- Achieving a better understanding of the relative risk associated with the ORR in order to enhance off-site emergency planning and response
- A.S. The Grantee shall identify local concerns and issues relevant to the operation of the Oak Ridge Reservation and environs and present concerns to the State of Tennessee and the Department of Energy during the selection of annual work and budget priorities.

ORCCA will continue to engage with the State and DOE to improve understanding of local government and community concerns.

During FY14 ORCCA particular emphasis will be placed on:

- Environmental Management activities that will help facilitate and expedite interpretation of historic properties
- Reindustrialization and transfer of excess/underutilized property for economic and community development purposes
- Continued emphasis on reducing/mitigating/eliminating off-site impacts
- CERCLA Footprint reduction

## A.6. The Grantee shall prepare special studies and reports, as needed, to educate local officials and further public information.

During FY14 particular emphasis will be placed on:

- A better understanding of how financial performance bonds are assessed on companies which store and treat DOE waste
- Legislative and Administrative activities related to the temporary storage and permanent disposal of nuclear waste
- The EMDF (Environmental Management Disposal Facility), which is the designation for the proposed second onsite disposal facility. Current milestones:

Proposed Plan (PP)- 11/30/13

Record of Decision (ROD)- 12/30/14

Remedial Design Work Plan (RDWP)- 9/30/15
