 - i. John Owsley (TDEC) reported on the Phased Construction Completion Report (PCCR) for the Oak Ridge Reservation Environmental Management Waste Management Facility. TDEC is waiting on the operations and monitoring report for the year. Groundwater levels in the northeast corner of the facility appear to be elevated. The facility liner and the water table should have a 10ft buffer. Sampling and monitoring around the perimeter will continue.
 - ii. Focus areas- TDEC environmental monitoring efforts focus on radiation and mercury contamination. There are sources of pollutants on the ORR that could be released if engineering and/or administrative controls fail.
- b) Emergency Planning (TEMA):
 - i. **Steve Oglesby** reported that TEMA is working on the joint Y-12 Exercise (EPIC16) afteraction report. Also stated the MJERP is nearing final review

Quarterly Report for Oak Ridge Reservation Communities Alliance (ORRCA) FY16 Q4 (April through June 2016)

During this quarter, a membership meeting was held on May 31, 2016. Public notice of the meeting was provided to local news media and the meeting was open to the public.

At the May meeting, members heard reports from state and federal agencies. Steve Oglesby (TEMA) reported that the updated Multi-Jurisdiction Emergency Response Plan is under review. John Owsley (TDEC) reported that the State is working with DOE on the renewal of the Tennessee Oversight Agreement and new grant to go into effect July 1, 2016. Bud Yard (TEMA) discussed the fall intern program, and introduced a student interested in an internship position. David Adler (DOE) gave an update about East Tennessee Technology Park activities, including the demolition of K-27. Nick Sisco, the Mapping Technician, presented his final report on storm water issues related to the Oak Ridge Reservation.

During this quarter, a number of additional activities related to the ORRCA scope of work took place. Multiple members attended an April public meeting sponsored by the Nuclear Regulatory Commission on licensing activities related to the proposed Small Modular Reactor. Member jurisdictions participated in the quarterly emergency response planning meeting organized by TEMA and DOE. DOE officials attended a work session of the Oak Ridge City Council to discuss the City's Community Impact Assessment and the status of the proposed Environmental Management Disposal Facility (EMDF). In addition, TDEC installed two additional signs along Bear Creek in Oak Ridge.

Business items approved at the May meeting include (1) minutes from the February 2016 ORRCA meeting; (2) the fiduciary report presented by City of Oak Ridge staff; (3) approval of reimbursements for technical reviews related to the ORRCA scope of work; (4) approval of the governmental contract and extension of the Tennessee Oversight Interlocal Agreement; (5) ORRCA budget and work plan; and (6) allocation and reimbursement of funds for the next grant period.

Several meeting were held related to the Manhattan Project National Historical Park (MPNHP), including meetings with the Interim Park Superintendent.

In addition, during this quarter, members and staff from ORRCA jurisdictions participated in several Energy Communities Alliance activities related to the ORRCA scope of work, including participation in a DOE meeting on Environmental Management issues in May.

Finally, all paperwork related to the renewal of the ORRCA grant for the five-year period beginning July 1, 2016, was submitted to the appropriate TDEC staff at the beginning of June 2016.
