- a) EMDF Landfill

 - 2. Extra teams have been chartered.
 - 3. Proposed milestone for RIFs is June 30, 2021.
 - i. Document was deemed incomplete.
 - ii. RIFs will determine problem with the Scope.
- b) Mercury
 - 1. Currently working on which strategy to take as far as the removal of Mercury and restrictions of Mercury.
- c) Tru Waste
 - 1. TRU waste shipments to WIPP were shipped on June 11, 2021.
 - 2. A total of 3,397 drums have been shipped to WIPP.
 - 3. FY21 102 shipments to WIPP have been made.
 - 4. No contact or remote handling milestones for 2021.
- d) K-25 Site
 - 1. Proposed plan for main plant groundwater is December 2021.
 - 2. Soil ROD is wrapping up now.
 - 3. Water ROD milestone is 2022 but not final.
