Site Treatment Plan for Mixed Waste on the United States Department of Energy Oak Ridge Reservation- Submittal of the Annual Update and the Semiannual Progress Report

Annual Update (Version 27.0) of the Site Treatment Plan (STP) for Mixed Waste on the United States Department of Energy (DOE) Oak Ridge Reservation (ORR) and the Semiannual Progress Report for the Period April 1, 2022 to September 30, 2022 were received by the Tennessee Department of Environment and Conservation (TDEC)'s divisions of Remediation (DoR) and Solid Waste Management (DSWM) in the following manner:

- DOE Oak Ridge Office of Environmental Management (OREM)'s portion of the Semiannual Progress Report and the Annual Update (Version 27.0), Sections 1, 2, 3, 4A, 5, Appendix A, Appendix B, Appendix C with a cover letter dated October 26, 2022.
- DOE Oak Ridge National Laboratory Site Office (OSO)'s portion of the Semiannual Progress Report and the Annual Update (Version 27.0), Section 4.b – Transuranic Mixed Waste Streams with a cover letter dated October 31, 2022.

These submittals fulfill the relevant requirements of section 2.3.2 of the STP titled, "Timing of Updates." For the purpose of review and approval process, the individually submitted chapters of Annual Update (Version 27.0) by OREM and OSO were integrated to form a single document titled, "Site Treatment Plan for Mixed Wastes on the U.S. Department of Energy Oak Ridge Reservation." Similarly, the separately submitted portions Semiannual Progress Report by OREM and OSO were combined to create a single document titled, "Semiannual Progress Report for the Period April 1, 2022 to September 30, 2022."

TDEC staff has reviewed the submittals and, in accordance with the Section 2.8.5.1 of the STP titled "Tennessee Department of Environment and Conservation actions," approves the Annual Update (Version 27.0) of the STP as submitted. The Semiannual Progress Report is accepted in its current form.


