RE: Federal Facility Agreement Milestone Extension Request for Addendum to the Final Zone 1 Remedial Investigation and Feasibility Study for a Supplemental Ecological Evaluation at the East Tennessee Technology Park, Oak Ridge, Tennessee (RI/FS D3/A1/R1) (DOE/OR/01-2561&D3/A1/R1)

The Tennessee Department of Environment and Conservation (TDEC) Division of Remediation, Oak Ridge Office, has reviewed the above referenced extension request (letter from J. Hardin and R. Petrie to S. Urquhart-Foster and R. Young) pursuant to Section XXX of the Federal Facility Agreement (FFA). The U.S. Department of Energy (DOE) submitted the request on September 27, 2024, and was received by TDEC the same day.

Based on review of the extension request letter, TDEC recognizes that additional time is needed to resolve responses to comments provided by the U.S. Environmental Protection Agency and TDEC on the RI/FS D3/A1 and for DOE to prepare a revised, approvable RI/FS D3/A1/R1 document. TDEC approves the extension request for submission of the RI/FS D3/A1/R1. The new document submittal date moves out 90 days from October 17, 2024, to January 15, 2025.
