RE: Federal Facility Agreement Milestone Extension Request for the Remedial Investigation Work Plan (RIWP) for White Wing Scrap Yard (Waste Area Grouping 11), Oak Ridge, Tennessee (DOE/OR/01-2970&D2)

The Tennessee Department of Environment and Conservation (TDEC), Division of Remediation-Oak Ridge Office, received the above referenced extension request (letter from J. Hardin and R. Petrie to S. Urquhart-Foster and R. Young) on September 30, 2024. The request has been reviewed pursuant to Section XXX of the Federal Facility Agreement for the Oak Ridge Reservation.

Based on review of the extension request letter, TDEC recognizes that additional time is needed to resolve responses to comments provided by the U.S. Environmental Protection Agency and TDEC on the RIWP D1 and for the U.S. Department of Energy (DOE) to prepare a revised, approvable RIWP D2 document. The State agrees with the good cause for extension included in the request and approves extending the milestone out 60 days from October 28, 2024, until December 27, 2024.
