**TDEC Concurrence: Addendum to the Remedial Design Report for the Construction of the East Tennessee Technology Park to Environmental Management Waste Management Facility (ETTP-EMWMF) Haul Road on the Oak Ridge Reservation, Oak Ridge, Tennessee Haul Road Reroute (DOE/OR/01-2228&D1/A2)**

Dear Mr. Petrie

The Tennessee Department of Environment and Conservation (TDEC), Division of Remediation-Oak Ridge Office, approves this Addendum, which addresses the rerouting of a portion of the Haul Road to accommodate the footprint of the Environmental Management Disposal Facility (EMDF). This reroute is required by the EMDF Record of Decision (ROD) ([DOE/OR/01-2794&D2/R2](#)) and outlined in the Early Site Preparation (ESP) Remedial Design Report/Remedial Action Work Plan ([DOE/OR/01-2934&D2](#)).

The Haul Road was originally added to the Environmental Management Waste Management Facility (EMWMF) ROD ([DOE/OR/01-1791&D3](#)) via an Explanation of Significant Differences ([DOE/OR/01-2194&D2](#)) in 2005. This Addendum is part of the EMDF ESP scope, and it updates the administrative record for EMWMF.
