TDEC Approval: Baseline Groundwater Monitoring Report for the Environmental Monitoring at the Environmental Management Waste Management Facility, Oak Ridge, Tennessee (DOE/OR/01-2021&D5)

Dear Mr. Petrie

The Tennessee Department of Environment and Conservation (TDEC) Division of Remediation -Oak Ridge Office (DoR-OR) reviewed the subject baseline groundwater monitoring report in accordance with the Federal Facility Agreement (FFA) for the Oak Ridge Reservation. The State approves this document and supports prompt integration of the baseline/evaluation values into the Environmental Management Waste Management Facility (EMWMF) detection monitoring program.

The revised baseline data will support improvements in the evaluation of potential impacts to groundwater from landfill operations. This will reduce uncertainties and bolster confidence in the long-term protectiveness of the EMWMF. The correction of the 0.005 µg/L MCL for lead in Section 3.1.5 is noted and appreciated, though this value does not appear to have been updated in Table 1 (Baseline/Evaluation Values for Key COCs).

TDEC understands the U.S. Department of Energy is revising the Sampling and Analysis Plan/Quality Assurance Project Plan (SAP/QAPP) to comply with legal requirements for managing landfill wastewater discharges in accordance with the U.S. Environmental Protection Agency (EPA) Administrator's December 31, 2020, decision. TDEC also understands the detection monitoring program described in the SAP/QAPP will incorporate the revised groundwater baseline/evaluation values.
