The Tennessee Department of Environment and Conservation (TDEC) Division of Remediation, Oak Ridge Office has reviewed the above referenced Federal Facility Agreement (FFA) Appendix E milestone addition request (letter from M. McIntosh and R. Petrie to S. Urquhart-Foster and R. Young) pursuant to Section XXX of the FFA. The U.S. Department of Energy (DOE) submitted the request on July 2, 2025, and was received by TDEC the same day.
