**RE: Federal Facility Agreement Milestone Extension Request for the Beta-1 Complex Pre-Demolition Phased Construction Completion Report at the Y-12 National Security Complex, Oak Ridge, Tennessee**

The Tennessee Department of Environment and Conservation (TDEC), Division of Remediation-Oak Ridge Office, received the above referenced Federal Facility Agreement (FFA) milestone extension request (letter from J. Hardin and R. Petrie to E. Marcillo and S. Urquhart-Foster) on October 27, 2025. The document has been reviewed pursuant to Section XXX of the FFA and Appendix I-1 for the Oak Ridge Reservation (ORR).

The need for this milestone extension is due to unanticipated delays involving the management of water infiltration, thorium-contaminated pipes, and mercury-contaminated pipes in the basement. TDEC agrees with this good cause in accordance with Section XXX.B of the FFA and approves the extension request. The U.S. Department of Energy (DOE) submittal date for this report moves from January 13, 2026, to November 30, 2026.
