RE: Proposed Geotechnical Survey and Pre-Construction Work at Certain Parcels in Roane County, Tennessee

The Tennessee Department of Environment and Conservation (TDEC) Division of Remediation, Oak Ridge Office is in receipt of the above referenced letter dated November 21, 2025. TDEC received the transmittal on November 24, 2025. Oklo, Inc. requested TDEC approval to conduct geotechnical survey and pre-construction work, including geotechnical borings and surface excavation within previously title-transferred Economic Development (ED) parcels ED-13 and ED-16 near the East Tennessee Technology Park. The geotechnical soil test borings and excavation will occur in parcels 1.55 and 1.55.1 which have been determined to be uncontaminated with U.S. Environmental Protection Agency concurrence under Comprehensive Environmental Response, Compensation, and Liability Act 120(h)(4). The Quitclaim deed provision for parcels ED-13 and ED-16 states "Grantee shall not extract, consume, expose, or use in any way the groundwater underlying the property or water from any streams or ponds located on the property without the prior written approval of DOE, the United States Environmental Protection Agency, and the Tennessee Department of Environmental and Conservation."

TDEC grants approval to conduct geotechnical survey and pre-construction work including soil boring and excavation within parcels 1.55 and 1.55.1. If additional soil disturbance activities outside the scope of this approval letter is necessary, then TDEC requires a subsequent approval request detailing the proposed work and site locations. As discussed on December 1, 2025, TDEC looks forward to working with Oklo, Inc. on further approval requests if additional geotechnical survey and pre-construction work are necessary within parcels not covered by this approval letter that may require soil and water management.
