RE: Extension Request for Explanation of Significant Differences for the Record of Decision for the Disposal of Oak Ridge Reservation Comprehensive Environmental Response, Compensation, and Liability Act of 1980 Waste, Oak Ridge, Tennessee: Clean Water Act (DOE/OR/01-2972&D3)

The Tennessee Department of Environment and Conservation (TDEC) Division of Land Protection – Remediation Branch, Oak Ridge Environmental Field Office received the Explanation of Significant Differences (ESD) on April 15, 2026. As detailed in emails dated April 29, 2026, TDEC requests two minor errata to make the document approvable.

Pursuant to FFA Section XXI, this document is subject to a 30-day period for review and comment. The due date for TDEC review is May 15, 2026. TDEC requests to extend the due date by 30 days to June 15, 2026, pursuant to FFA Section XXX, Extensions. Granting the requested extension would not delay attainment of any scheduled FFA milestones. Good cause for extension exists because the requested errata will support TDEC approval of the ESD.
